### 1 Information about the collection of personal data

(4) When you contact us by e-mail or through a contact form, we will store the information you provide (your e-mail address, your name and telephone number if applicable) to answer your questions. We delete the data that arises in this context after the storage is no longer required, or limit the processing if there are statutory retention requirements.

(5) If we rely on commissioned service providers for individual functions of our offer or like to use your data for advertising purposes, we will inform you in detail below about the respective transactions. In doing so, we also name the specified criteria for the storage duration.

### 3 Collection of personal data when visiting our website

(1) In the case of merely informative use of the website, i.e. if you do not register, register or otherwise provide information to us for the use of the website, we will not collect any personal data, with the exception of data transmitted by your browser to our server. If you wish to view our website, we collect the following data that is technically necessary for us to inform you about our website and to ensure the stability and security (legal basis is Art. 6 para. 1 lit. f of the DSGVO):

- IP address
- Date and time of the request
- Time zone difference to Greenwich Mean Time (GMT)
- Content of the request (concrete page)
- Access status / HTTP status code
- Each transferred amount of data
- Website from which the request comes
- Browser
- Operating system and its interface
- Language and version of the browser software.

(2) In addition to the aforementioned data, cookies are stored on your computer when you use our website. Cookies are small text files that are stored on your hard drive assigned to the browser you are using and by which the body that sets the cookie (here through us) receives certain information. Cookies cannot run programs or transmit viruses to your computer. They serve to make the Internet offer more user-friendly and effective overall.

(3) Use of cookies:

1. a) This website uses the following types of cookies, the scope and mode of operation, which are explained below:
  - Transient cookies (see b)
  - Persistent cookies (see c).
1. b) Transient cookies are automatically deleted when you close the browser. These include, in particular, the session cookies. These store a so-called session ID, with which various requests from your browser can be assigned to the common session. This will allow your computer to

be recognized when you return to our website. The session cookies are deleted when you log out or close the browser.

1. c) Persistent cookies are automatically deleted after a specified period, which may differ depending on the cookie. You can delete the cookies in the security settings of your browser at any time
1. d) You can configure your browser setting according to your wishes. B. decline the acceptance of third-party cookies or all cookies. Please be aware that you may not be able to use all features of this site.

#### **4 Other functions and offers of our website**

(1) In addition to the purely informational use of our website, we offer various services that you can use if you are interested. To do this, you will generally need to provide other personal information that we use to provide the service and for which the aforementioned data processing principles apply.

(2) In part, we use to process your data from external service providers. These have been carefully selected and commissioned by us, are bound by our instructions and are regularly inspected.

(3) Insofar as our service providers or partners are based in a country outside the European Economic Area (EEA), we inform you about the consequences of this circumstance in the description of the offer.

#### **5 Objection or revocation against the processing of your data**

(1) If you have given your consent to the processing of your data, you can revoke them at any time. Such revocation affects the admissibility of the processing of your personal data after you have given it to us.

(2) Insofar as we base the processing of your personal data on the balance of interests, you may object to the processing. This is the case if, in particular, the processing is not required to fulfil a contract with you, which we present in the following description of the functions. In the event of any such disagreement, we ask you to explain the reasons why we should not process your personal data as we have done. In the case of your justified objection, we examine the situation and will either discontinue or adapt the data processing or point out to you our compelling legitimate reasons on which we continue the processing.

## 6 Web-Analytics
